I. COMPANY PROFILE

Mishra Dhatu Nigam Limited (MIDHANI) was incorporated under the Indian Companies Act, 1956 with the objective of manufacturing and sale of high technology metals alloys and their products, components to all strategic sector customers and to enable these customers to source strategic materials, which are not easily accessible. MIDHANI is a schedule - 'B' Mini-Ratna CPSE with the administrative jurisdiction of Department of Defence Production, Ministry of Defence.

Its Registered and Corporate offices are at Hyderabad, Andhra Pradesh.

The authorised and paid up share capital of the Company was Rs.200 crores and Rs. 187.34 crores respectively as on 31.03.2019.

The company employed 791 regular employees (Executives: 257, Non- Unionized Supervisors: 65, Non-executives: 469) as on 31.03.2019.

The shareholding of the Government of India in the company is 74% as on 31.03.2019.

II. JOB DESCRIPTION AND RESPONSIBILITIES

The Chairman and Managing Director is the Chief Executive of the Corporation and accountable to its Board of Directors and Government/ Share holders. He is responsible for the efficient functioning of the Corporation, and for achieving its corporate objectives and performance parameters.

III. ELIGIBILITY

2. EMPLOYMENT STATUS:

3. QUALIFICATION:

Applicant should be a graduate with good academic record from a recognized University/Institute.

Applicants with Technical/MBA qualifications will have added advantage.

4. EXPERIENCE:

Applicants should have adequate experience at a senior level of management in a large organization of repute.

Applicants with experience in Finance/Marketing/Production will have added advantage.

Experience in metal/ alloy/ aerospace/ aeronautics/ atomic energy Sector is desirable.

5. PAY SCALE/ RANK/ LEVEL:

The minimum length of service required in the eligible scale/rank/level will be one year for internal candidates, and two years for others as on the date of vacancy.

IV. DURATION OF APPOINTMENT

Further, if a candidate conveys his/her unwillingness to join after the issue of offer of appointment, he/she would be debarred for a period of two years from the date of offer of appointment for being considered for a Board level post in any CPSE other than the one to which the candidate belongs.

3. For candidates from SPSE/ Private Sector

- a. If a candidate conveys his/her unwillingness to join after the interview is held, he/she would be debarred for a period of two years from the date of interview, for being considered for a Board level post in any CPSE.
- b. Further, if a candidate conveys his/her unwillingness to join after the issue of offer of appointment, he/she would be debarred for a period of two years from the date of offer of appointment for being considered for a Board level post in any CPSE.
- 4. In the above cases, no request for relaxation or otherwise would be entertained.
