I. COMPANY PROFILE

(a) Indo-Russian Rifles Private Limited (IRRPL) is an assault rifle-manufacturing facility in Korwa, Amethi district, Uttar Pradesh, India. This Joint Venture was incorporated in 2019 under Inter Governmental Agreement for manufacturing AK-203 assault rifles for the Indian Armed Forces. It is a Joint Venture (JV) between Advanced Weapons and Equipment India Limited (42.5% stake), Troop Comforts Limited (8% stake), Concern Kalashnikov (42% stake) and Rosoboronexport (7.5% stake).

(b) Its registered office is at 301A, Stateman House, Barakhamba Road, New Delhi – 110001, CIN Number – U29100DL2019PTC346537. The paid up capital of the company is Rs. 100 Crore.

II. JOB DESCRIPTION AND RESPONSIBILITIES

The CEO/MD shall be the Chief Executive of the Company and will report to the Board of Directors. The CEO will be one of the Directors and shall be designated as Managing Director (MD). The CEO/MD shall function under the superintendence, control and directions of the board and in accordance with the Articles of Association of the company. The day to day management of the company will be carried out by the CEO/MD.

III. ELIGIBILITY

(a) **Qualification:** The applicant should be an Engineering Graduate or a Post Graduate in any discipline.

(b) **Experience:**

(i) **Essential** Should have worked for at least 5 years as the Chief Executive Officer in manufacturing companies/equivalent higher position in the Indian Armed Forces.

(ii) **Desirable** 25 years of professional experience in manufacturing/handling of weapon system.

(c) **Minimum Age of Applicant:** 54 years as on date of issue of advertisement.

(d) **Maximum Age of Applicant:** 58 years as on date of issue of advertisement.

(e) **Employment Status:** The applicant must, on the date of application, as well as on the date of interview, be employed in a regular capacity – and not in a contractual/ad-hoc capacity – in one of the following: -

(i) Central Government including the Armed Forces of the Union and All India Services;

(ii) Defence/Central Public Sector Enterprise;

(iii) State Public Sector Enterprise where the annual turnover is *Rs 500 crores or more;

(iv) Private Sector company where the annual turnover is *Rs 500 crores or more.

(* The average audited annual turnover of three financial years preceding the calendar year in which the post is advertised shall be considered for applying the approved limits)

IV. **PAY SCALE**

(b) **Applicants from Central Government / All India Services** should be holding a post of the level of Joint Secretary in Government of India or carrying equivalent scale of pay on the date of application.

(c) **Applicants from the Armed Forces of the Union** should be holding a post of the level of Major General in the Army or equivalent rank in Navy/Air Force on the date of application.

(d) **Applicants from State Public Sector Enterprises/ Private Sector** should be working at Board level position on the date of application.

V. **DURATION OF APPOINTMENT**

(a) In case, a Central Government officer selects the tenure on deputation, the tenure will be for a period of three (3) years from the date of joining. The term is extendable twice for a duration of 1 year each, with the approval of the Board of IRRPL upto a maximum age of 60 years or until further orders.

(b) In case of a Private Individual or CPSE officers or SPSE officers or in case a Central Government officer joining on immediate absorption basis, the appointment shall be for a period of 5 years from the date of joining or upto a maximum age of 60 years or until further orders, whichever is earlier.

VI. **UNDERTAKING BY THE APPLICANT**

(a) An applicant has to give an undertaking as part of the application that he/she will join the post, if selected.

(b) If an applicant does not give such an undertaking, the application would be rejected.

SEARCH-CUM-SELECTION COMMITTEE (SCSC)

VII. The SCSC reserves the right to shortlist applicants for interview. It is free to identify and recommend any other person also, based on merit, who may not have applied for the post. The committee may relax the eligibility and qualification/experience criteria, in respect of outstanding candidates, if considered necessary.

 - (v) Private Sector: directly to DDP.
- (b) Applicants from Private Sector must submit the following documents along with the application form:

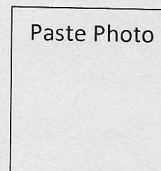
