#### I. COMPANY PROFILE

Goa Shipyard Limited (GSL) was created with the objective to manufacture quality ships and hi-tech components for defence and commercial sectors at competitive prices. GSL is a Schedule-"B" CPSE under the administrative jurisdiction of Department of Defence Production, Ministry of Defence.

Its Registered and Corporate Offices are located at Vasco Da Gama, Goa.

The Company employed 1302 regular employees (Executive-225 & Non- Executives 1077) as on 31.03.2024.

The authorized and paid up capital of the Company is Rs.60 crores and Rs.58.20 crores respectively as on 31.03.2024.

The shareholding of the Government of India in the Company is 51.09% as on 31.03.2024.

#### II. JOB DESCRIPTION AND RESPONSIBILITIES

Director (Operations) is a member of the Board of Directors and reports to the Chairman and Managing Director of GSL. He/ She will hold complete charge of Operations vertical of the Company related to shipbuilding, which includes design, planning, production, trials and delivery of ships as per contractual schedules, maintaining high quality standards. Besides overseeing Departments directly coming under his/ her charge, he/ she will also be responsible for procurement of equipments/ materials, outsourcing of services, quality assurance and inspections related to construction of ships. He/ She will be required to oversee facilities formulation of long term and annual plans, in line with emerging industry trends, and ensure implementation through evolving suitable strategies and effective monitoring mechanism. He / She will be responsible for industrial relations including management of industrial workforce and ensure adherence to Industrial Occupational Safety norms and statutory provisions.
